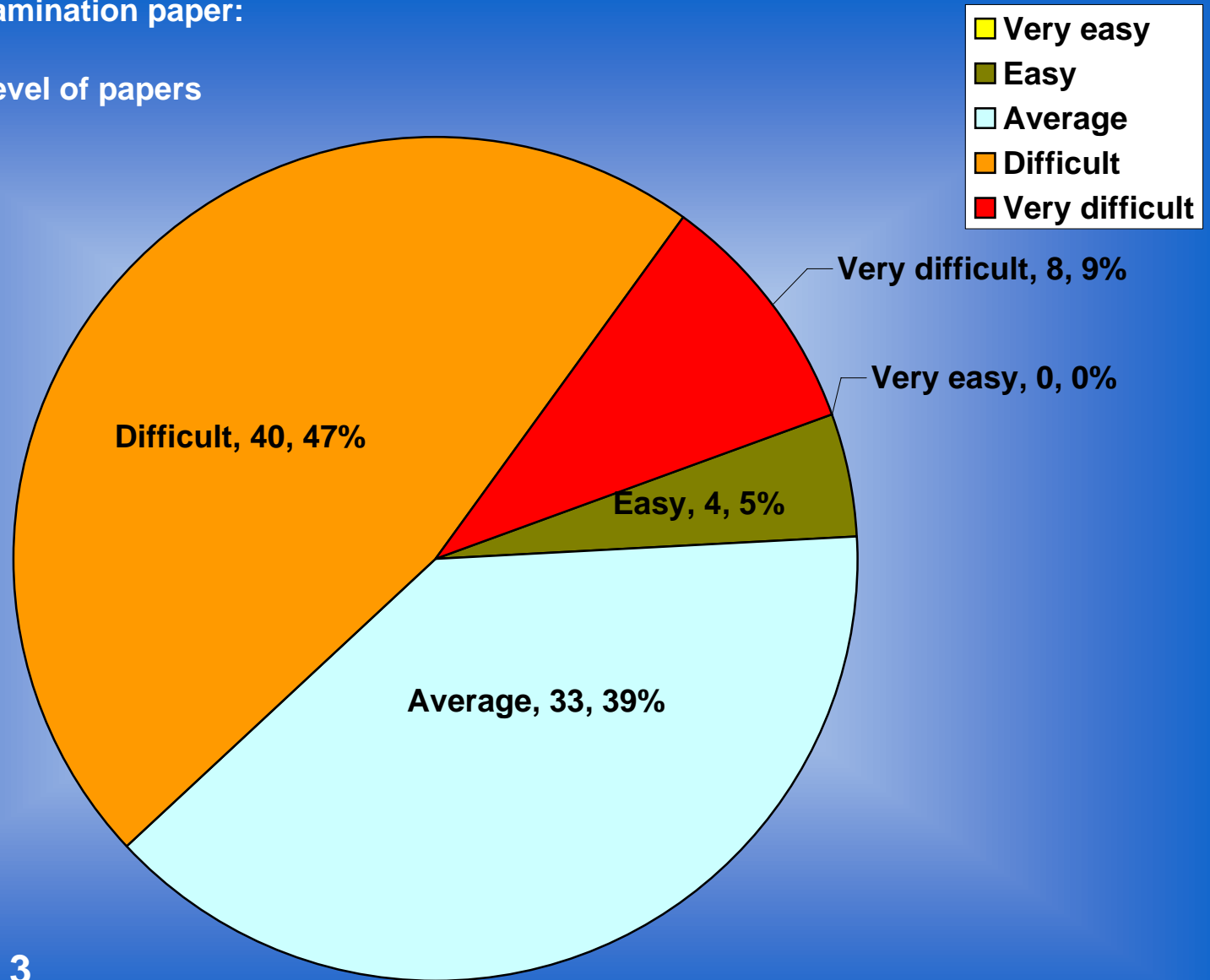
Rate difficulty level of papers
